# FINDING FOLLOWING EVIDENCE REVIEW

# Finding as at 5/08/2019: Concerning non-compliance

• If non-compliance has been identified, this analysis describes evidence of the non-compliance.

#### Clause 1.1

The RTO's training and assessment strategies and practices, including the amount of training they provide, are consistent with the requirements of training packages and VET accredited courses and enable each learner to meet the requirements for each unit of competency or module in which they are enrolled.

## **Finding: Compliant**

#### Outstanding non-compliance

Provider response does not demonstrate compliance with Clause 1.1 the training and assessment
strategy for example but not limited to; does not distinguish the different learner cohorts' specific
industry experience. Mapping matrix and delivery schedule presented are generic samples and does
not align with each different learner cohort. The training and assessment strategy does not specify
how non-accredited and/or in-house training is mapped to each unit of competency. The training and
assessment practice is different to the documented training and assessment strategy and student
assessments.

- a) the existing skills, knowledge and the experience of the learner
- b) the mode of delivery
- c) where a full qualification is not being delivered, the number of units and/or modules being delivered as a proportion of the full qualification.

# Outstanding non-compliance

 Provider response does not demonstrate compliance with Clause 1.2, the training and assessment strategy for example; but not limited to, does not distinguish the different learner cohorts' existing skills, knowledge and the experience of the learner non-accredited and/or in-house training.

Provider response does not demonstrate compliance with Clause 1.3 the trainers and assessors for
example but not limited to; have not undertaken professional development activities since July 2015,
resumes refer to last date as July 2015 and commencing a qualification and no mapping of vocational

  - Revised and updated mapping documents align with the trainer and assessor resources and the unit of competency requirements including assessment requirements.

• The organisation has provided evidence to demonstrate compliance with this clause.

Clause 1.4

The RTO meets all requirements specified in the relevant training package or VET accredited course.

#### **Finding: Compliant**

#### Outstanding non-compliance

Provider response does not demonstrate compliance with Clause 1.4 meets all requirements specified
in the relevant training package or VET accredited course, for example but not limited to; students
have not been sufficiently assessed against HLTPHA008, student assessment task identified 17 of 20
questions do not align with mapping document and the assessment requirements for HLTPHA008.

# Outstanding non-compliance

• Provider response does not demonstrate compliance with Clause 1.8 with demonstrated evidence of implements an assessment system that ensures that assessment (including recognition of prior learning): but not limited to; students have not been sufficiently assessed against HLTPHA008, student assessment task identified 17 of 20 questions does not align with mapping document and the assessment requirements for HLTPHA008. Students files supplied does not demonstrate students are competent in this unit of competency. Provider is not able to demonstrate Principles of Assessment and Rules of Evidence and complies with the assessment requirements of HLT47115 Certificate IV in Hospital/Health Services Pharmacy Support and HLT47515 Certificate IV in Operating Theatre Technical Support.

# Clause 1.9 The RTO implements a plan for ongoing systematic validation of assessment practices and judgements that includes for each training product on the RTO's scope of registration: a) when assessment validation will occur b) which training products will be the focus of validation c) who will lead and participate in validation activities d) how the outcomes of these activities will be documented and acted upon.

# Finding: Compliant

#### **Outstanding non-compliance**

 Provider response does not demonstrate compliance with Clause 1.9 for example but not limited to; provider has not submitted a validation schedule or demonstrating each training product is validated at least once every five years, with at least 50 per cent of products validated within the first three years of each five year cycle.

  - Revised and updated mapping documents align with the trainer and assessor resources and the unit of competency requirements including assessment requirements.

assessment practice and inaccurate assessments and implementation of sufficient training and
assessment strategies and practices to ensure ongoing compliance.
